Chrystia Freeland

Chrystia Freeland was born in Peace River, Alberta, and studied at Harvard University, from which she received a B.A. in History and Literature. She was awarded a Rhodes Scholarship to continue her studies at St. Anthony's College, Oxford University, where she earned a Master's degree.

Chrystia Freeland serves as editor of Thomson Reuters Digital and Global Editor-At-Large of Thomson Reuters Corporation. She also serves as Reuters principal on-air pundit for other external broadcast partners. Additionally, Ms. Freeland serves as senior contributor to Reuters.com where she writes a weekly column that focuses on critical issues taking place at the intersection of business and politics. From 1999 to 2001, Ms. Freeland served as deputy editor of The Globe and Mail. Ms. Freeland is the author of Sale of a Century: the inside story of the second Russian revolution (2000), which details Russia's journey from communism to capitalism. Her second book: Plutocrats: The Rise of the New Global Super-Rich and the Fall of Everyone Else is being released this October. Freeland sits on the advisory board of the Rotman School of Management at the University of Toronto and is a board member of the Women's Refugee Commission and the Overseas Press Club of America. She has been honoured as a Young Global Leader by the World Economic Forum.
